Emergency Preparedness— by Councilperson George Langford

As I have stated before on our city web site most of our residents have some sort of MSD concrete culvert, or drainage ditch in their front yards, back yards, or behind their properties. Residents are responsible for keeping debris out of these ditches on their properties so that the water can flow out of our city unimpeded and into the detention basins around our city or into storm drain pipes. It also helps our city if the drainage ditch

behind your properties is cleared out and also makes for a great neighbor!

On another matter it would help if all of us would at least once per week pick up the refuse (garbage) that accumulates in our streets and in our yards. This refuse includes cigarette butts, soft drink/beer cans, bottles, etc.

All our new street signs have been installed and we are looking into getting new block watch signs for the city.

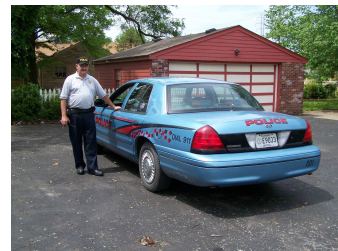

Police Department— Chief “Bob” Robert L. Heaton

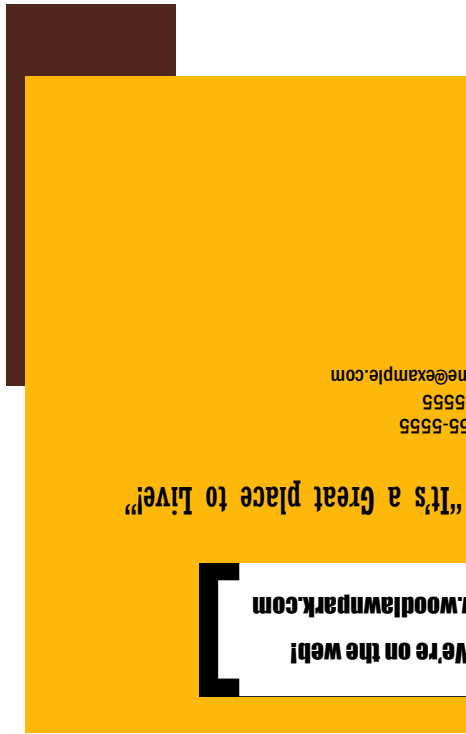
