

SEPTEMBER 2020 WOODLAWN PARK VIRTUAL COUNCIL MEETING MINUTES

The Woodlawn Park City Council met virtually on Monday, September 21, 2020. Present were: Mayor Larry Lewis, Council Members: Mike Brown, Greg Claypool, George Langford, Tom Nunn, Ed Purcell, and Doug Watson. Also in attendance were Chief Mike Koenig, Gloria Curran, Pat Merrick, and attorney Matt Carey.

Mayor Larry Lewis called the meeting to order at 7:00 p.m. The online meeting began with the Pledge of Allegiance, followed by a roll call of the Council Members.

The Council reviewed the minutes for the August 17, 2020 meeting. George Langford made a motion to accept the minutes and Tom Nunn seconded the motion and the minutes were accepted. The minutes for the Special Meeting on Monday, September 14, 2020 to nominate Ed Purcell to fill the vacancy of Shannon Seidt were also accepted.

Gloria Curran gave her Treasurer's Report for August 2020. Doug Watson made a motion to accept the report and Tom Nunn seconded the motion and the report was accepted.

Pat Merrick reported she had one Open Records Request and she sent them the ORR form, but has not received it back yet.

Chief Mike Koenig gave his report for August 2020. City Citations: 4, City Warnings: 6, State Citations: 0, All Assists: 4, Police Backup: 1, Arrests: 0, Miscellaneous: 2, Reports: 0, Gasoline: \$80.26, Gallons: 33.667. He had Miscellaneous Expenses of \$250.89 for the purchase of a body-worn camera to be part of his uniform. He also stated that he could be called upon to assist other agencies in case of civil unrest due to the Breonna Taylor verdict.
